Highlights of 2007

- ◆ Implemented Records and Registration which included robust Self -Service functionality for students, faculty, and advisors.
- ◆ Tuition Calculation process allows our Student Accounts and Registrar offices to leverage the integration of ISIS and eliminate extensive and error-prone manual processes. This allows the Student Accounts offices to see tuition charges as students enroll and credits from dropped courses flowing automatically into a student's account based on enrollment entries.
- ◆ Redesign the ECSI promissory note interface to streamline the process of students electronically signing promissory notes for loans. In addition, the new interface improves error reporting, adds support for paper promissory notes, and moves the execution of the interface to the automatic job scheduler. With this new, improved interface, SAS users spend more time assisting students with their financial aid and less time trouble shooting.
- ◆ Successful Admissions (SMS) Implementations for both SAIS Bologna and Nursing.
- ♦ On-line admissions application for Peabody.
- ◆ Simplify the ISIS Change Control process in order to maximize efficiency of operations while maintaining control of the environment. This will distribute the work and reduce or eliminate bottlenecks in the process.

Payments for Spring 2008 (or 3rd Quarter) are flowing into each office, and Registration is progressing rapidly for all of the divisions. We wish everyone a prosperous and Happy New Year, and look forward to working with Nicole Westrick in her new position as ISIS Business Solutions Manager.

Self-Service Updates

The Self-Service team has been working on expanding Advisor Self-Service to other divisions. With original deployment to Engineering and Arts and Sciences, the Advisor Self-Service has been recently expanded to SAIS, with further expansion to advisors at the School of Public Health planned for January.



In the past month, the Faculty Grade Roster was used to post over 30,000 grades. Feedback during this time was mostly positive with some performance issues being identified during loading and posting of larger rosters. The Self-Service team has analyzed these performance issues and has technical solutions in testing now. These solutions will be moving to production in

time for the next set of grading periods.

The Self-Service team continues to release updated software on a weekly schedule.

Financial Aid Updates [SAS]

On January 7, 2008 we expect to receive the SAS 2626 winter regulatory release. This update will deliver the official 08-09 Federal needs analysis as well as the ability to import and export 08-09 ISIR records and corrections. The planted and testing data for this plant.

All divisions are encouraged to update their ISIS self service message boards with the following language:



"Receipt of your 2008-2009 FAFSA will be reflected in ISIS on or after February 12, 2008."

As many of you know, the College Cost and Reduction Act (CCRA) created the new Teacher Education Assistance for College and Higher Education (TEACH) Grant Program. This program is effective beginning with the 2008-2009 Award Year and provides up to \$4,000 a year in grant assistance to students who plan on becoming a teacher and meet certain specified requirements. As with the ACG and SMART grant programs, awards and disbursement records will be processed by the U.S. Department of Education's Common Origination and Disbursement (COD) system. Sun-Gard Higher Education will likely need to issue a late winter/early spring regulatory release.

Finally, a small work group is working to develop a Request for Information (RFI) that will be announced by the National Association of Student Financial Aid Administrators (NASFAA). The purpose of the RFI is to collect information from lenders regarding their private loan program offerings. Lender responses will be used to build a university-wide suggested list of private lenders. SAS Tip for the Month



Effective with the 2008-2009 award year, the interest rate on the Subsidized Direct Loan program goes to 6%. The interest rate on the Unsubsidized Direct Loan program will not change, and remains at 6.8%. Be sure to update your website, print materials and ISIS fund settings accordingly.

VSS Retirement - February 29, 2008!

The Visual SourceSafe (VSS) application will be retired on February 29, 2008. Beginning January 7, 2008, the ISIS Project will no longer promote changes originating from VSS. Module teams have been working to transition away from VSS to either Subversion, replacement system for application source code, or Confluence, replacement system for documentation and workbooks. Transition plans regarding the assets currently in VSS for each module will be discussed in their respective user group meetings.



Admissions Updates [SMS]



The December SMS Users Group meeting covered a variety of topics. Highlights included:

- ♦ A fix for the current and most recent previous schools flags is now in production. Complete details are available in JIRA CMN-2937.
- Delete Prospects and Applicant Records All testing on the delete prospects and applicants functionality must be completed by December 28, 2007. This functionality will move to Production in the first release of 2008.
- ◆ International Student Data Entry Over the past several months, there have been numerous changes to data entry for international applicants. Many of these changes were required to ensure that we have accurate data entry for our university-wide reporting. However, some of these changes resulted in a more cumbersome


- data entry process for the admissions offices. At the December Usergroup meeting, there were several changes suggested to simplify the data entry procedure. Development is happening on these changes and additional information on testing will be available in early 2008.
- ♦ Enhancing the online application many divisions are interested in further extending the capabilities of the online application to handle the electronic submission of requirements such as recommendation letters, resumes, essays, and so forth. In addition, there was an active discussion of the business needs for each office related to document management. This will be a topic that continues to be discussed at future SMS User Group Meetings.

If you feel you must store sensitive information on a mobile device, please make sure that the directory or file is encrypted and password-protected.
